PROVISIONAL ANNOTATED AGENDA

Background

Effective land administration is fit-for-purpose, appropriate and adequate, interoperable, sustainable, flexible, inclusive and able to accelerate efforts to document, record, recognize and monitor people-toland relationships in all their forms. Effective land administration provides humanity with better access to and security of land and property rights and supports the principle of leaving no one behind – one of the commitments under the 2030 Agenda for Sustainable Development. Under the FELA, a plurality of tenure types, globally agreed concepts and approaches are covered, the use of applicable internationally agreed standards is promoted and the need to respect the inherent rights of indigenous peoples to their lands, territories and resources, as well as their traditions and customs, is recognized. Land administration relates people to land and provides information on the how, what, who, when and where of land tenure, land use, land value and land development. Land administration systems are the basis for recording the complex range of rights, restrictions and responsibilities related to people, places and policies.

The United Nations Committee of Experts on Global Geospatial Information Management at its tenth session, with <u>decision 10/107</u>, welcomed and adopted the <u>Framework for Effective Land Administration</u> (FELA) and appreciated that FELA is fully aligned with the <u>United Nations Integrated Geospatial</u> <u>Information Framework</u> (UN-IGIF), whilst noting that transparent and secure land and property rights for all was a crucial component for an economically, socially and environmentally sustainable society. At its thirteenth session, the Committee of Experts with <u>decision 13/109</u>, reiterated that FELA is an important element of the work of the Committee of Experts and provides a valuable step forward in assisting and guiding Member States when developing, reforming, strengthening and modernizing effective and efficient land administration.

The fifth meeting of the United Nations Expert Group on Land Administration and Management is hosted by the National Institute of Statistics and Geography (Instituto Nacional de Estadística y Geografía) (INEGI) of Mexico with the support of the Mexican Cadastre Institute (Instituto Mexicano de Catastro) (INMECA) and the Permanent Committee of Cadastre in Latin America (El Comité Permanente de Catastro en Iberoamérica) (CPCI). The fifth meeting includes the Second International Seminar on United Nations Global Geospatial Information Management with the theme "Effective land administration'.

This fifth meeting of the Expert Group is a closed meeting for members of the Expert Group and invited participants including from the National Institute of Statistics and Geography, the Mexican Cadastre Institute, and the Permanent Committee of Cadastre in Latin America. This in-person meeting allows members of the Expert Group together with invited experts and participants to review, discuss and consider a number of substantive items that are presently before the Expert Group.



The Committee of Experts, when adopting FELA, requested that the Framework:

- i) Be a living document, periodically reviewed and updated, taking into consideration political, societal, economic, environmental and technological circumstances;
- ii) Address the rights of Indigenous peoples to lands, territories and resources which they have traditionally owned, occupied or otherwise used or acquired; and
- iii) Encourage the use of internationally recognized standards, including International Organization for Standardization standard 19152 and International Hydrographic Organization standard S-121;

In addition, the Committee encouraged the Expert Group to work through its identified inventory of issues and to consider the roles of effective land administration in the area of climate and the integration of the terrestrial, maritime and cadastral domains. The inventory of issues and thus the areas of focus for the Expert Group in its present three-year work plan are:

- i] Leadership, promoting and raising awareness of the merits and benefits of effective land administration through:
 - raise awareness of and advocate for the country-level implementation of the FELA together with the UN-IGIF;
 - role of effective land administration within the area of climate change and resilience, and sustainable development.
- ii] The implementation of the UN-IGIF and the FELA at the country-level:
 - leverage the Implementation Guide of the UN-IGIF as a reference resource when considering guidance to implement the FELA at the country level;
 - elaborate and align the UN-IGIF implementation guidance and recommended actions with national circumstances and needs;
 - address effective land administration within an "ecosystem" or "interconnected domains".
- iii] The integration of the terrestrial, maritime, built and cadastral domains; and additional issues related to:
 - rights, restrictions and responsibilities associated with land;
 - digital and mobile access to land information;
 - cybersecurity and data security mechanisms needed to protect vital land information;
 - integrated information on land tenure, land value, land development, land use and land use change.
- iv] Collaborating with other UN-GGIM functional groups and to work closely with relevant international organizations to further anchor the FELA in the broad programme of work of UN-GGIM.
