

INTERNATIONAL SEMINAR ON UNITED NATIONS GLOBAL GEOSPATIAL INFORMATION MANAGEMENT with the theme "Effective Land Administration"

Background

Economic and Social Council (ECOSOC) <u>resolution 2022/24</u>, adopted on 22 July 2022, reiterated the importance of strengthening and enhancing the effectiveness of the United Nations Committee of Experts on Global Geospatial Information Management (UN-GGIM), particularly for the achievement of its operations focused on the Sustainable Development Goals (SDGs) and the United Nations Integrated Geospatial Information Framework (UN-IGIF), to strengthen and ensure its continued effectiveness and benefits to all Member States. The resolution also updated and modernized the Committee's Terms of Reference (as annexed to the <u>resolution</u>), being the subsidiary body of ECOSOC in charge of all matters related to geospatial information, geography, land administration and related topics.

The United Nations Committee of Experts on Global Geospatial Information Management at its tenth session, with decision 10/107, welcomed and adopted the Framework for Effective Land Administration (FELA) and appreciated that FELA is fully aligned with the United Nations Integrated Geospatial Information Framework (UN-IGIF), whilst noting that transparent and secure land and property rights for all was a crucial component for an economically, socially and environmentally sustainable society. At its thirteenth session, the Committee of Experts with decision 13/109, reiterated that FELA is an important element of the work of the Committee of Experts and provides a valuable step forward in assisting and guiding Member States when developing, reforming, strengthening and modernizing effective and efficient land administration.

Effective land administration is fit-for-purpose, appropriate and adequate, interoperable, sustainable, flexible, inclusive and able to accelerate efforts to document, record, recognize and monitor people-to-land relationships in all their forms. Effective land administration provides humanity with better access to and security of land and property rights and supports the principle of leaving no one behind – one of the commitments under the 2030 Agenda for Sustainable Development. Under the FELA, a plurality of tenure types, globally agreed concepts and approaches are covered, the use of applicable internationally agreed standards is promoted and the need to respect the inherent rights of indigenous peoples to their lands, territories and resources, as well as their traditions and customs, is recognized. Land administration relates people to land and provides information on the how, what, who, when and where of land tenure, land use, land value and land development. Land administration systems are the basis for recording the complex range of rights, restrictions and responsibilities related to people, places and policies.

The International Seminar on United Nations Global Geospatial Information Management with the theme "Effective land administration", will provide an open forum for dialogue and deliberating key considerations leveraging the nine pathways of FELA to provide the reference and guidance for Member States to strengthen and enhance their land administration nationally or sub-nationally. The International Seminar seeks to share and exchange knowledge, information, and experience; facilitate peer-to-peer engagement and learning; interact and consider guidance, recommendations, standards and approaches towards effective land administration for the wellbeing of society, environment and economy.



The fifth meeting of the Expert Group on Land Administration and Management and International Seminar are hosted by the National Institute of Statistics and Geography (Instituto Nacional de Estadística y Geografía) of Mexico with the support of the Mexican Cadastre Institute (Instituto Mexicano de Catastro) (INMECA) and the Permanent Committee of Cadastre in Latin America (El Comité Permanente de Catastro en Iberoamérica) (CPCI).
