For land administration to be sustainable and have its desired impact for all, including the marginalised and vulnerable, requires dynamic, inclusive and energetic partnership. Strategic partnership is fundamental to support sustainable land administration, and to achieve the goals of the global development agendas, including the 2030 Agenda for Sustainable Development. Strategic partnership creates shared visions, shared opportunities and leverages on each other added values, to support the shared goal securing land and property rights for all.

The Expert Group has updated its work programme for the 2017-2018 biennium that was endorsed by the Committee of Experts at its seventh session. Within this work programme, the expert group considers the development of a Framework for Sustainable Land Administration that will be consulted, and then presented to the Committee of Experts for its consideration at its ninth session in 2019. The framework describes key requirements and pillars for sustainable and interoperable land administration and management systems that can efficiently and effectively document, record and recognize people-to-land relationships in all their forms. One of the pillars is focusing on strategic partnership addressing the needs, contribution and opportunities of such a framework.

The Expert Group wishes to engage and interact with delegates attending the eighth session of the Committee of Experts on the progress of the development of the framework. The side event will first provide a general introduction of the Expert Group and its activities, and will then focus on the development of the Framework for Sustainable Land Administration – current considerations and issues. Members of the Expert Group will share their perspectives. The side event will then conclude with summary and next steps. The outcome of this side event will contribute to the ongoing considerations by the Expert Group on the key requirements and pillars for sustainable and interoperable land administration and management systems towards securing land and property rights in all its forms, and for all.
