A. Background

The standards development organisations (SDO) of the Open Geospatial Consortium (OGC), International Standards Organisation Technical Committee 211 (ISO/TC211) and the International Hydrographic Organisation (IHO) have worked in partnership for more than two decades to ensure international geospatial standards are developed to meet the needs and requirements for data sharing within our global geospatial community. In 2015 the UN-GGIM endorsed the Guide to the Role of Geospatial Information Standards and its Companion Document - Standards by Tier. Following a survey of more than 50 member nations, the SDOs have now reviewed and updated the two documents with recent standards developments and case studies. The data gathered from the survey has assisted not only with the update of the guide, but also to inform the standards community on the use of geospatial standards and needs for further education and capacity building.

OGC ISO/TC211, and IHO standards are currently widely used in the world because they are deployed in software (both commercial and open source) that is used by millions of users every day. These standards that are in use enable both interoperability and accuracy and are the underlying support of GIS and Mapping across the globe.
