1. Election of officers

In accordance with resolution 2011/24 of the Economic and Social Council (ECOSOC), specifically the terms of reference contained in the annex of this resolution, the Committee of Experts on GGIM, at the commencement of each session, shall elect, from among its members, two co-chairs, respecting geographical balance and representation. Furthermore, since it is customary for ECOSOC subsidiary bodies to elect a Rapporteur, the Committee shall elect a Rapporteur.

4. Rules of procedure of the Committee

It is therefore opportune, that the Committee highlight recent developments in geospatial information management and, thus, help countries with tools and methodologies for the monitoring of goals and targets on sustainable development. The Committee is invited to express its views and to agree to the formation of a working group to further develop the Committee's contribution to Rio+20.
