

# HIGH-LEVEL GROUP OF THE INTEGRATED GEOSPATIAL INFORMATION FRAMEWORK (HLG-IGIF)

First Plenary Meeting 26 – 28 April 2022 UNHQ Conference Center, New York

# **Concept Note and Provisional Agenda**

#### **Preamble**

The United Nations Committee of Experts on Global Geospatial Information Management (UN-GGIM) has emphasized that the <u>United Nations Integrated Geospatial Information Framework (IGIF)</u> now provides an overarching paradigm to further strengthen nationally integrated geospatial information management, not only for Member States that were in the early stages of adopting national spatial data infrastructures (SDIs), but also for those that had already successfully implemented SDI capabilities, In this regard, continuous collaboration would be necessary, including with other emerging and complementary geospatial initiatives, to extend the IGIF's implementation and relevance in the future geospatial information ecosystem.

### Background

At its tenth session, in making <u>decision 10/103</u>, UN-GGIM noted the global significance of the IGIF, which serves as a key umbrella for the many activities under the purview the Committee of Experts, including the regional committees and thematic groups of UN-GGIM. Recognizing that the IGIF could be applied to any country to guide transformational change, the Committee of Experts endorsed the establishment of a dedicated high-level group of experts, with balanced geographical representation and expertise, as a mechanism to provide strategic leadership, coordination and oversight in order to ensure the sustained success of the IGIF, and to mobilize the resources necessary to maintain the momentum and refinement of the IGIF as a continuously evolving process.

At its eleventh session, in making <u>decision 11/103</u>, UN-GGIM welcomed the report of the High-level Group of the Integrated Geospatial Information Framework (<u>HLG-IGIF</u>) and recognized the efforts by the HLG-IGIF to quickly establish itself and develop an ambitious plan to provide the strategic leadership and guidance, at this fundamental phase of the IGIF, which continued to be globally important and adopted. UN-GGIM endorsed the <u>Strategic Plan of the HLG-IGIF</u>, including its six defined goals and focus actions, as an essential step towards the continued success and relevance of the IGIF, and supported the three priority goals identified for immediate attention – improve communication, strengthen capacity development and mobilize sustainable funding – as a means for developing the HLG-IGIF initial plan of work to guide its focus and activities for the next one to two years.



#### Sustaining the momentum and impact

UN-GGIM, at its eleventh session, also emphasized the importance of maintaining the impact and continuity of the IGIF at the national level and applicable for all Member States, and noted suggestions for the HLG-IGIF to consider in its plan of work:

- The refinement and finalization of the Implementation Guide of the IGIF remains a high priority for Member States and an important basis for the development of a global community for sharing knowledge and harmonizing the integration of geospatial information at the country level, without which there was a risk that the core focus of the IGIF might become diluted and inconsistent in its adoption and implementation;
- ii) The pressing need to obtain sustained funding for the implementation and iterative development of the IGIF so that it endured as a living instrument, was reviewed in a constant process, kept up to date and based on the practical implementation experiences of Member States;
- iii) Noting that the geospatial community often faces challenges in effectively communicating and promoting knowledge and awareness of the IGIF, especially with decision makers in nongeospatial global institutions, the convening of IGIF forums at the global and regional levels to share good practices and successful strategies for IGIF implementation at the country level would be beneficial in strengthening capacity development;
- iv) Noting the variability in the levels of national circumstances and conditions (governance, technology, capacity, etc.) between developed and developing countries when establishing a country-level action plan, a set of performance indicators or diagnostic measures might assist countries as they determine which priority goals, activities and actions to apply in their respective Integrated Geospatial Information Framework country-level action plans;
- v) Embedding the IGIF, as a tangible framework, into existing United Nations conventions, agreements and frameworks, such as the Sustainable Development Goals and the Intergovernmental Panel on Climate Change, to guarantee high-level political awareness of the IGIF and its long-term sustainability;
- vi) Clear mechanisms to provide adequate resources to support the implementation of the IGIF in developing countries, to develop national country-level action plans that could be effectively operationalized and, with a view to having a significant impact for geospatially enabled e-services, embarking on a path towards digital transformation and to bridge the geospatial digital divide;
- vii) That the HLG-IGIF continued to engage with the regional commissions and the regional committees of UN-GGIM to promote and implement the IGIF and support the strengthening of regional geospatial information management.

# First plenary meeting of the HLG-IGIF

The first plenary meeting of the HLG-IGIF, to be convened from 26 – 28 April 2022 at the UNHQ Conference Center in New York, will allow members of the HLG-IGIF, together with the UN-GGIM Bureau and the members of the Friends of the co-Chairs Group, to renew their acquaintance, engage, interact and work with one another to review, consider and discuss progress to-date, develop and plan for the work ahead, noting the global importance of the IGIF for strengthening national geospatial information management towards implementing national development priorities and the 2030 Agenda for Sustainable Development.

The plenary meeting is a closed meeting, by invitation only, and will facilitate ongoing consideration to translate concepts into practical guidance for the implementation of the IGIF at the country level. It will enable peer-to-peer exchange of information, experience and practices, and afford networking whilst attending to the business the HLG-IGIF.

#### Meeting of the UN-GGIM Bureau and the Friends of the co-Chairs Group

Within the programme of the first plenary meeting, and recognizing the high-level representations from Member States, the UN-GGIM Bureau will also convene a meeting of the Friends of the co-Chair Group, tasked by UN-GGIM (decision 11/101) to lead preparations and consult on the draft report of UN-GGIM to the United Nations Economic and Social Council (ECOSOC) on the implementation of <u>E/RES/2016/27</u> and the strengthening of the institutional arrangements of the Committee of Experts.

### Organizers

The United Nations Global Geospatial Information Management Section, Statistics Division, Department of Economic and Social Affairs, as the Secretariat for UN-GGIM, together with the UN-GGIM Bureau, will jointly organize the first plenary meeting that will incorporate the meetings the UN-GGIM Bureau and the Friends of the co-Chairs Group.

### Language

The meetings will be conducted in English.

# Participation

Members of the UN-GGIM Bureau, the HLG-IGIF and Friends of the co-Chairs Group are invited to participate in this three-day event. Interested national representatives of Member States wishing to participate and contribute to the meetings may request to the Bureau and be invited to the meetings.

#### **Provisional agenda**

The provisional agenda for the first plenary meeting of the High-level Group of the Integrated Geospatial Information Framework is as follows:

- 1) Welcome and introductions.
- 2) Adoption of agenda and related organizational matters.
- 3) The IGIF, 2030 Agenda for Sustainable Development, and national development priorities an overarching paradigm to strengthen nationally integrated geospatial information management.
- 4) Implementing and sustaining the impact and continuity of the IGIF at the country-level.
- 5) Continuous collaboration with emerging and complementary initiatives interlinkages to extend relevance in the future geospatial information ecosystem.
- 6) Review of the IGIF Strategic Plan, plan of work, tasks and accomplishments the three priority goals for immediate attention improve communication, strengthen capacity development and mobilize sustainable funding; and the next three goals promote data governance, availability and accessibility, encourage collaboration, exchange and sharing; and oversee improvement and review.
- 7) Twelfth session of UN-GGIM, summary, next steps and close.
