Challenges in the implementation of the UN-IGIF (St. Lucia NSDI Action Plan)

1. Lack of Political Will and Institutional Support

- The NSDI Policy and Action Plan remained stagnant prior to Cabinets' endorsement.
- World Bank deemed NSDI implementation as an enabling component for funding under the "Disaster Risk Management Development Policy Credit with Catastrophe Deferred Drawdown Option Program" (Cat DDO)

2. Regulatory and Policy Barriers

Strategy 2. Policy and Legal

 Adopt Saint Lucia 2014 Datum/Projection as part of the amended Land Surveyors Act / Land Registration Act

Strategy 6. Standards

 Adopt and implement a modern datum/projection as standard coordinate reference system (CRS) and fit them in international CRS databases.
