Note by the Secretariat

1. The proposed organization of work for the tenth session of the Committee of Experts on Global Geospatial Information Management (see annex) has been prepared pursuant to relevant decisions of the General Assembly and the Economic and Social Council in order to facilitate the consideration of agenda items within the time and services allocated to the Committee.

The second informal meeting of the tenth session will be on Thursday, 27 August 2020, at 10:00 a.m. also for two hours. The third and final informal meeting of the tenth session will be convened on Friday, 4 September 2020, the exact timing to be finalized.
