Background

The importance of geospatial data in the achievement of the global development goals needs little justification to those attending the Committee of Experts meeting. However, in the wider global arena it is not as readily acknowledged. The Millennium Development Goals Report was clear that data are an indispensable element of the development agenda, and that:

'Knowing where people and things are and their relationship to each other is essential for informed decision-making.' (page 12)

The Sustainable Development Goals are even more wide ranging, and most, if not all, will require geospatial information to support policy decision-making, implementation of actions, and measuring and monitoring. The need for a set of fundamental geospatial data themes to underpin and support geospatial information has been acknowledged and reiterated by the Committee of Experts in its meetings since 2014. Indeed, work to identify these themes has taken place in all Regions of the world, and the Committee directed that this widespread activity should form the base of the current task.

At the fifth session of UN-GGIM, the Committee of Experts agreed that there was:

'an urgent need for a set of global fundamental geospatial data themes that could be harmonized in order to enable the measurement, monitoring and management of sustainable development in a consistent way over time and to facilitate evidence-based decision-making and policy-making'

To achieve this, UN-GGIM: Europe was asked to take the lead for this task and directed to draw on the existing work of the Regions with a view to producing a minimum list of global fundamental geospatial data themes.
